

SECTION 001116 - INVITATION TO BID

Sealed Bids will be received by **Elsmere Fire District**, at the Offices of the Board of Fire Commissioners, located at 15 West Poplar Drive, Delmar, NY 12054, (Phone: 518-439-9144) until **4:00 p.m.** local time on **Tuesday, August 14, 2018**, and then, at said office, publicly opened and read aloud for:

Elsmere Fire District previously awarded Multiple Prime Contracts for Bids received on June 22, 2018, as follows:

CONTRACT NUMBER AND TYPE:

Contract 2 – Plumbing
Contract 3 – HVAC
Contract 4 – Electrical
Contract 5 – Pre-Engineered Building System

Bids will be received on a Stipulated Sum basis, including unit prices, alternates and allowances, in accordance with the Summary of Work as described in the Contract Documents.

The Work shall be substantially complete, for occupancy and use by the Owner, within **200** calendar days, in accordance with the Milestone Project Schedule included in the Bid Documents, and completed and ready for final payment within **230** days after the date when the contract time commences to run. The Contractor(s) and the Contractor(s)' surety, if any, shall be assessed liquidated damages for each calendar day of delay after the date established for substantial completion in the Documents until the work is complete.

The labor on this contract shall be performed in all respects in full accordance with the Labor Law of the State of New York. Contractors must conform to the New York State prevailing wage rate schedules which are annexed to and form a part of the specifications for this project.

Bids should not include New York State sales and compensating use taxes on materials incorporated into the work.

Bids actually received by mail or by hand after the appointed time on the date specified shall be rejected, notwithstanding that such Bid may have been placed in a mail box or other mail receptacle regularly maintained by the United States Postal Service before such time, and ordinarily in sufficient time to have been delivered on time.

Bid security in the amount of **5%** of the Bid must accompany each Bid in accordance with the Instructions to Bidders.

The successful Bidder will be required to furnish a performance bond and a payment bond, each in an amount equal to **100%** of the contract price.

Revised Drawings and Specifications, incorporating the changes and modifications from the prior Bids received, may be examined on and after **Monday, July 16, 2018**, during normal business hours at the following locations:

In accordance with Section 103-d of the General Municipal Law, at the time Contractor submits its bid, an authorized and responsible person shall execute and deliver a non-collusive bidding certification on Contractor's behalf.

A Pre-bid Conference will not be scheduled, however, Bidder's are encouraged to visit the site on their own, though no provisions for on-site parking is currently available.
